## OUTREACH 800 PROJECT

Attention all Nicotine Anonymous meeting groups!

Is outreach important to our continuing smobriety? Should we use as many means as possible to reach active smokers and struggling ex-smokers and other nicotine users?

Which is easier and simpler to tell a smoking friend:

"I'll get you a copy of the area meeting directory." (with the possibility of either you forgetting or the friend losing the urge to quit before you give the directory)?

or

"When you want to stop smoking and would like to check out Nicotine Anonymous, just call I-800-XXX-XXXX to find out about meetings in your area." (and hand him/her a card that you had on you because it was easy to carry)?

which is easier to carry around and distribute in smoker areas two-page copies of the  $8\frac{1}{2}$ x11 Meeting Directory or index or busness cards with a short simple message and 800 number?

Which is easier for a potential Nicotine Anonymous member — to place a toll call to a hotline number with limited circulation and listen to a litary of 10 different meetings before the one that applies to her or him comes up? or to call a single free 800 number that gives a simple welcoming message that promises a callback by a volunteer in her/his area?

sample of index card message:

STIL SMOKING BUT WANT TO STOP? WANT TO STAY NICOTINE FREE?

A friendly, non-judgemental support group might be the answer for you.

NICOTINE ANONYMOUS is such a group. No dues. No fees.

For info on meetings in your area, call 1-800-XXX-XXXX.

YOU CAN DO IT!!

Sample outgoing message for callers to the 800 number:

"Welcome! You have reached the Nicotine Anonymous info line. If you want information on meetings in your area, or would just like to talk to someone about the program, then -- after the tone -- leave your name, phone number and city, and the best time to reach you. A volunteer from your area will return your call as soon as possible. Thank you for calling. You can succeed!"

Now, in order to make this Outreach 800 project happen, we need your support. We need a minimum financial commitment from every meeting group -- no matter how small -- of a least \$5.00 per month. Larger groups are requested to take a Group Conscience to decide how much additional contribution they could regularly make for this specific project. We know this will be a stretch for some groups. But think of the potential for reaching smokers!

However, for right now we just want a show of interest and tentative support. We can't move ahead until we know the level of support for this public outreach project.
