# Southern California Intergroup of Nicotine Anonymous Minutes for March 21, 1999 Meeting

Minutes of the Southern California Intergroup of Nicotine Anonymous meeting held on March 21, 1999 at White Memorial Hospital in Los Angeles.

Acting Chair Bonnie opened the meeting at 10:00 am with the Serenity Prayer. Delegates introduced themselves, their groups and the length of their smobriety. There were 22 delegates present.
