Corrected minutes of the Southern California Intergroup of Nicotine Anonymous meeting held on Oct. 15, 2000, at White Memorial Hospital, 1720 E. Cesar Chavez Ave., Los Angeles.

During the discussion, Phil P. wanted to know about handicapped access and if we could use an asterisk when a room is handicapped available. It was pointed out that this is already being done.

The issue was moved, seconded, and approved to make this permanent policy for SCINA.

Gary agreed to hold contributions and donations for Annette until the November meeting. He said he would also hold any bills until he sees her.

Discussion on what to put in new meetings packet centered on how thick and clumsy we want it to be. No decision today and the matter was dropped.

Gary asked about literature for the Nov. 18 marathon and it was moved, seconded, and approved to appropriate \$50 for this purpose. More discussion on the marathon concerned what food would be available and should we plan to bring our own. John N. said the church has two large refrigerators and they should be more than adequate for our purposes.

Jan said that she would have the Treasurer's Report attached to the minutes after the November meeting.

Jean L. agreed to present a view of Tradition Eleven at the November SCINA meeting. It was moved, seconded, and approved to discontinue the practice of subsidizing refreshments for all future SCINA meetings when they are held at White Memorial Hospital. Meeting was adjourned at 11:54 a.m.
