Minutes of the Southern California Intergroup of Nicotine Anonymous meeting held at White Memorial Medical Center, 1720 E. Cesar Chavez Ave. Boyle Heights, California.

1. Marc S. opened the meeting at 10:10 a.m.

3. Traditions

Donations and receipts which were submitted at the January meeting will be reflected on the February report. We will not make a donation to NAWSO until after the conference. We need to pay the hospital for past rent. It was moved seconded and approved to reimburse Marc for \$60 to cover the cost of the plaque. The retreat will be funded out of SCINA's general account as long as the World Services conference is using the events account. Jean L. will keep track of the retreat funds within the SCINA account. It was moved, seconded and approved that the treasurers report be accepted The motion passed unanimously.

8. Committee Reports

- A. New Meetings: Gary M. reported he followed up on one kit sent out last month. A new meeting has begun on Tuesday night at Laguna Woods.
- B. Public Outreach: Marc S. reported for Liz T. that we have received information from Patience Mc., a member who has done a lot of work for Nicotine Anonymous in the past, regarding the placing of free notices in the newspapers. She is willing to bird-dog notices for 6 months in the LA Times and the Toluca Times. She submitted suggested copy as follows: "Nicotine Anonymous, ongoing support for anyone with a desire to stop smoking,. Over 40 meetings weekly in Southern California. No dues or fees. Call 800-642-0666 or www.nicotine-anonymous.org." Michelle suggested that the copy refer to" smoking or using nicotine". With this one change it was moved seconded and approved to place this copy in the LA Times. A slightly longer copy for the Toluca Times was read, and revised. It was moved seconded and approved to accept the copy as follows:" Nicotine Anonymous, open to all who have a desire to stop smoking or using nicotine in any form. Nicotine Anonymous, a non-profit fellowship based on the 12 steps, provides ongoing support in over 40 weekly Southern California meetings, Including several throughout the San Fernando Valley. No dues or fees. Call 800-642-0666 or www.nicotine-anonymous.org." Mary D. commended Patience for her willingness to donate her expertise to this project.

There was discussion regarding wording for the announcement in STEPS magazine. It was decided to just announce Nicotine Anonymous is having a World Services Conference with the date, location and WEB site.

George L reported that Ty K will no longer be able to do the second Tuesday of the month panel at the Salvation Army in Long Beach and so volunteers are again being requested. Steve H. reported he had received a call from someone at Phoenix house requesting a panel. Mary D. will follow up on this.

Stella, Hospitality Chair is a soliciting volunteer. George L. Literature Chair will be requesting material for the table. He has 7 volunteers and could use more. Doug is still looking for volunteers to lead a marathon meeting. Marc S. asked for approval for the wording for the T-shirts. Hats are being donated by John Neal. They will be sold at \$10. A letter opener was also circulated that is being donated and will be put in the registrant's packet complements of SCINA. Gary M. reported that he currently has 6 persons registered.
