We now have a Literature Committee Coordinator and he is asking us to email him with our thoughts and suggestions.

Outreach: Our PSA CD is completed and for sale on the website and through World Services. We are to take the CD to radio stations and ask them to play it. Outreach does have money available for projects once approved. WSO will pay up to \$500 for each project. Project request forms are on the website.

Seven Minutes: The newsletter editor will be retiring next year but would like to train someone for this position. She is always looking for more articles. The "Discussion Corner" is new and is for readers to submit their thought about Nicotine Anonymous related issues.

Meeting List: It is important the World Wide Meeting list be kept up to date. Change forms are on the website.

Teleservice: There are telephone meetings for those areas that do not have meetings. The teleservice coordinator is asking for help with returning calls that come into our information line. The cost of calls will be reimbursed by World Services.
